Since 2006 we've worked with over 3,020 local charities and community groups across Sussex, covering a range of needs and causes. We use this insight alongside national and local data to focus our impact on four funding priorities where we believe we can make the biggest difference: Tackling Poverty, Improving Health, Reaching Potential and Acting on Climate.

Through our philanthropy advice we help to match our supporters' aims with the many small, effective local charities offering solutions to local issues.
